
Questions to answer before you decide a Strategy when Bullish

- What Should Volatility Levels do when the Move happens?
- Capital to Employ?
- Risk Tolerance?





XYZ Bullish Call Vertical



Bullish XYZ Butterfly (2 Weeks till Expiration)


