
Today we'll showcase a methodology to utilize AI to assess the intraday swing in major markets

### Premise: Leading Indicators



Toggle's Leading Indicators are built from bottom up fundamental datapoints, and can provide info about the future moves of the market

Can we estimate if today will be more or less volatile than the median of the last month?


Turns out, we can!
